## **CALL TO ORDER**

## **NEW BUSINESS**

- Review of regulations from September 4th, 2024 draft.
  - o Review of certification fee and renewal time frames.
    - Based on budgetary requirements and to keep cost down.
  - Discussion regarding regulation on insurance liability requirements for radon measurement specialist. Concern presented that the regulation requirement would put small businesses out of business due to the cost of insurance.
  - Statute is in place for Board to interpret for regulations.
  - Kentucky Revised Statute 309.442 covers insurance requirement Evidence of financial responsibility.
  - No exceptions regarding insurance requirement in following Kentucky Revised Statute 309.444.
  - o Inquiry was made if statute can be opened vs going through regulation regarding insurance. Opening a statute is a different process then proclamation of regulations.
    - Opening statute would have to take place during Legislative General Assembly.
      - Question for legal counsel.
      - Chris Nolan shared the Board can vote for the chair, members, or voted member to go to the Legislative General Assembly to ask/seek change of the statute. Legislative General Assembly is currently in session and not to late as Legislative General Assembly comes back together on February 4th, 2025.
      - Discussion to remove measurement from KRS 309.442.

- Kyle Hoylman entertained motion for Chair (Kyle Hoylman) to attend and advocate to Legislative General Assembly the revise statute by removing measurement from 309.442. Bruce Furgesson made motion. Vance Walker seconded. Roll call vote:
