Ms. Stewart reported the board's website URL, radon.ky.gov, has been secured and the website is being created. The website will take approximately three weeks to complete. No action taken.

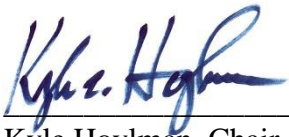
NEW BUSINESS
