**CALL TO ORDER**

Vance Walker called the meeting to order at 2:08 p.m.

**APPROVAL OF MINUTES**

Steve Rice motioned to approved November 13, 2024 Special meeting minutes. Stacey Stanifer seconded motion. Motion carried.

**OLD BUSINESS**

- Website Links – Organized by professional / consumer needs. Removal of FreeRadonTestKit.com, added in the Center for Disease Control (CDC) Radon, NRSB certification page, and NRPP certification page.
  - Bruce Fergusson made motion to accept changes to website links listed on the DPL Radon webpage. Stacey Stanifer seconded motion. Motion carried.
- Radon Awareness Month Letter
  - Item was to be addressed during Special meeting in November 2024 that was unable to be held. No action taken.
- Vance Walker read update from Chair Kyle Hoylman regarding Grants.gov hold up.
  - Board Specialist explained that the Board has not signed into contract with the DPL or OLS. To sign into contact with DPL and/or OLS the regulations needs to be adopted, file with LRC, and go through the LRC process to be accepted.

**AD HOC ADMINISTRATIVE REGULATIONS COMMITTEE**

- Review of regulations from Septemeber 4th, 2024 draft.

- Discussion regarding regulation on insurance liability requirements for radon measurement specialist. Concern presented that the regulation requirement would put small businesses out of business due to the cost of insurance.
- Insurance liability is included in the Kentucky Revised Statute 309.442
  - Would require opening the statute to change.
  - Wording of regulation can be written as interpreted by the board to support/enforce the statute, but can't directly conflict with statute.
  - Discussion on the interpretation of general liability and air & emission insurance to satisfy regulation & statute.
- Direct vs General Supervision
  - Covered under the ANSI standards.
    - Direct supervision is on site, certified, and has staff under direct supervision.
    - General supervision is a person/staff receives instructions and direction from a supervisor, but the supervisor is not always present.

Bruce motioned to adopt the current regulations as drafted. Vance Walker seconded motion. Steve Rice opposes. Move to vote .

Motion carried with a vote of 2-1-1 to adopt the current regulations as drafted.
