- Special meeting discussion/schedule

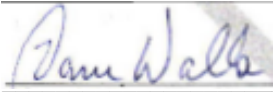
- Set for July 30, 2025, at 9am. Noted, unless board members that are absent today are unable to attend, Board Administrator is to send out new dates and times.
